TERRY GAVE THE MANAGERS REPORT: ADAPCO HAD A TRAING SEMINAR THAT TERRY AND GERALD WATCHED ON THE 21ST ON THE COMPUTER REGARDING CHEMICAL RESISTANCE AND TESTING. WEST NILE VIRUS CONFERENCE ON THE 22ND CDC AND HEALTH DEPARTMENT ON EXPANDED TRAPPING AND TESTING IN THE REST OF THE COUNTY. RISK MANAGEMENT REVIEW CAN HELP WITH EMPLOYEE HANDBOOKS.
